## Third Meeting of the ERN Coordinators Group

11 October 2017 – Brussels, Belgium

The third meeting of the ERN Coordinators Group was held on 11 October 2017 Brussels. On behalf of ERN GUARD-HEART, **Arthur Wilde**, the Coordinator, and **Ahmad Amin**, the project manager of the Network, participated at the meeting.

#### **Governance of ERN Board of Coordinators**

Following the election of **Maurizio Scarpa**, Coordinator of MetabERN, as the Chairman of ERN Coordinators Group on 21 June 2017, at this meeting Franz Schaefer, coordinator of ERKNet was elected as the Vice-Chair.

#### **Board of the Member States Meeting**

At the ERN Coordinators Group, a short summary was provided about the meeting of the Board of the Member States. Important points for discussion were 1) the legal entity of ERNs, 2) the sustainability of ERNs, and 3) the integration of ERNs with the National Health Systems. A working group of ERN Coordinators will be established to write position papers on these three topics on behalf of the ERNs to present to the European Commission and the Board of Member States.

#### **Other topics**

Other agenda points at the 3<sup>rd</sup> ERN Coordinators Group meeting were:

- update of the activities of the different Working Groups (i.e., Ethics, Research, IT & data sharing, Cross-border healthcare & business continuity, Knowledge generation, and Monitoring and quality improvement),
- update on the IT platform and CPMS,
- update on the new call for HCPs to join existing ERNs.

# Teleconference with thematic area leaders

# European Joint Programme Cofund

31 October 2017, Amsterdam, Netherlands

The objective of this is to design and implement a Rare Disease European Joint Programme (EJP) Cofund, which contains future Horizon2020 transnational calls for research projects. This means that in the current Call only funding bodies in national Member States can participate to implement the EJP Cofund and determine the content of the future calls and the amount of money involved per call.

However, ERNs can act as partners to contribute to the application writing process (to contribute to the content of Horizon2020 future calls for transnational research on rare diseases). In this context, ERN GUARD-Heart will also participate in the advisory panel to assist in the application writing process. ●



## **Extension of ERN GUARD-Heart**

## 20 November 2017, Amsterdam, Netherlands

The call for new full Members to join existing ERNs is expected to be announced in December, open in March 2018 and close in June 2018. For ERN GUARD-Heart this means not only that the number of healthcare provides (HCPs) per thematic area will increase, but also that new thematic areas will be included.

Formal representatives of Grown-up Congenital Heart Disease (GUCH) community (i.e. of the ESC and AEPC) have sent an official request to join ERN GUARD-Heart. In addition, several expertise centres across Europe



have approached the Network to obtain information about the future inclusion criteria.

At this moment, the ERN GUARD-Heart is in the process of defining and evaluating specific criteria for the HCPs that will establish the 'new' thematic area GUCH. These specific criteria, together with the criteria for the HCPs that aim to enter the currently existing thematic areas, will be discussed at the third Board Meeting of the ERN GUARD-Heart on 20 December. ♥

## **IT Collaborative Platform**



This is a restricted online space for communications and administrative document management with the ERNs. Each ERN has a specific work space for its Members. ERN GUARD-Heart members should follow the next steps to access the IT Collaborative Platform:

- 1. Create an EU Login using the link: <u>https://webgate.ec.europa.eu/cas/</u>
- 2. Go to the link: <u>https://webgate.ec.europa.eu/ern/</u> and use your EU Login to enter the Platform

3. Click 'Access/request access to my network' Requests for membership will be authorized by the ERN Coordinator.

It is of utmost importance that all ERN members gain access to the IT Platform, as the numbers of access requests and document views will be used as a key performance indicator by the European Commission to assess the ERNs. So far, 11 GUARD-Heart members have requested access. ♥

## **Clinical Patient Management System**

Secure Login

You can Login to the CPMS ERN through the EU Login Authentication Service.

#### Login via EU Login

CPMS enables medical and non-medical specialists from ERNs to exchange information to diagnose and treat patients. **The European Commission (EC) will release the 1<sup>st</sup> version of the CPMS on 20 November 2017.** This means that from this date ERNs are able to use CPMS to transfer patient files between the different HCPs within the ERN to diagnose or treat patients (as a second opinion service). Multiple ERN specialists can contribute to the assessment of patient files (ECGs, echocardiograms, microscopy files, and radiology files) through comments, formal contributions, and reviews of the outcome documents. Participation is possible through written comments or panel meeting via live video conferences. When cases are closed, they can be anonymized for research.

Patients have no direct access to CPMS. The EU Login system will be used for authentication. Patient data will be pseudonymized before entering CPMS. A patient consent form, designed by EC in collaboration with the ERNs (for both care and research) will be required for patient data uploads. ♥
